

**REVISED BYLAW 15-20
AS OF APRIL 8, 2020**

**BYLAW 15-20
BEING A BYLAW OF THE TOWN OF OKOTOKS
IN THE PROVINCE OF ALBERTA
REGARDING PENALTY CHARGES FOR UTILITIES
IN THE TOWN OF OKOTOKS**

WHEREAS pursuant to the provisions of the *Municipal Government Act*, Revised Statutes of Alberta 2000 Chapter M-26 and amendments thereto, the Council of the Town of Okotoks passed Bylaw 24-18, the Water Bylaw, for the purpose of provision and regulation of a water utility within the Town of Okotoks; and

WHEREAS the Council of the Town of Okotoks passed Bylaw 09-19, the Fees, Rates, and Charges Bylaw, for the purpose of establishing fees, rates, and charges for services provided by the Municipality; and

WHEREAS the Council of the Town of Okotoks deems it desirable to amend the Bylaw 24-18 and Bylaw 09-19 to provide financial relief to Town utility account holders due to the COVID-19 pandemic;

NOW THEREFORE the Council of the Town of Okotoks enacts as follows:

1. That under section 3.9 of Bylaw 24-18 the following subsection be added and all subsequent subsections renumbered accordingly:
 - 3.9.6 Despite sections 3.9.2, 3.9.3, 3.9.4, and 3.9.5 and due to the COVID-19 pandemic, the utility billing due dates will be delayed for 3 months from the utility due dates of March 31 and May 29, 2020.
2. That Schedule 'A of Bylaw 09-19, under Utilities, Water, Sewer, Storm Water, and Waste Management, be amended with the addition to the utility penalty provisions as follows:


