# How to use this document

The Community Sustainability Plan is designed to adapt to, grow with, and meet the challenges faced by the Town of Okotoks over time.

In 2015, the Town of Okotoks commissioned a new **Community Sustainability Plan (csp)**, a document that will direct the future development of municipal strategies, goals, and policies using a rigorous framework for action across economic, environmental, social, and cultural sectors in Okotoks. The csp is supported by the **2014 Community Visioning Process** that engaged hundreds of citizens to create a **new vision and set of guiding principles** that will form the basis of many municipal initiatives.

Through a phased six-month process, the Community Sustainability planning team worked with public stakeholders, municipal staff, and elected officials to identify current strengths and constraints at work in the town to create and refine a plan that will guide Okotoks toward a sustainable future.

The Community Sustainability Plan stands out from its peers. It is a living document built using an adaptive framework for action; a series of **critical steps** build upon themselves in an incremental process. Progress in each critical step is measured using a series of indicators; as success is achieved, the critical steps are renewed and replaced as necessary. This incremental approach towards sustainability planning and implementation will allow the Town of Okotoks to work towards the realization of the long-term community vision by breaking down emerging challenges into manageable pieces and overcoming them.

In the following pages, you'll reacquaint yourself with the community vision and guiding principles, learn about sustainability and resilience in practice, understand the influences affecting the future development of Okotoks, and see how the first round of sustainability planning begins a process of positive change.



## Community Vision

"The Town of Okotoks is resilient, where people, businesses, ideas and sense of community thrive. Grounded by the Sheep River valley and supported by thoughtful planning and design, a strong local economy and a vibrant civic culture, Okotoks offers exceptional quality of life at every stage of life. Respect for each other and the natural environment makes Okotoks home."

In 2014, the Town of Okotoks engaged hundreds of citizens over four months to establish a new vision for the future of the community. The result of the process was a vision and set of guiding principles that are to be used for all initiatives of the Town of Okotoks, including this Community. Sustainability Plan. Everything found within this plan has a focus on moving Okotoks towards the vision and guiding principles.

#### LIVABLE OKOTOKS

People make Okotoks the caring, safe and welcoming place that it is. Public spaces are cherished, natural features are valued, and community needs are met. An appropriate mix of land uses, mobility options, infrastructure and accessible, affordable and equitable services provide the foundation for sustainable growth. High-quality educational opportunities support life-long learning. The transportation network is multi-modal, allowing for the environmentally responsible and cost-effective movement of people and goods.

#### **VIBRANT CIVIC CULTURE & HERITAGE**

Residents joyfully embrace Okotoks, and cultivate a rich quality of life. Okotoks provides access to a wide range of cultural resources, fostering audiences, participants and creators who contribute to community building and economic development. The strong tradition of community events is a hallmark of living in Okotoks. Residents are engaged in civic life, and Town Council and administration promote open dialogue.

#### INCLUSIVE NEIGHBOURHOODS

Neighbourhoods are connected, fostering a sense of community among residents. Housing is flexible, affordable and desirable, and meets the needs of residents of all ages, income levels and family types. Design and architecture create places that reflect neighbourhood culture. Community gathering spaces are animated and anchor neighbourhoods. Streets are lively and engaging places, where people can move around in a safe and inclusive environment. New communities are permeable and connected to encourage active transportation.

#### ACTIVE LIFESTYLE

Residents enjoy an active lifestyle that nurtures community well-being. Health and wellness facilities support the needs of residents at every stage of life. Opportunities for sport and play are accessible in high-quality recreation facilities, multi-use civic buildings and a complete parks and open space network. These public spaces strengthen the bond between residents, and to the places they share.

#### ENVIRONMENTAL STEWARDSHIP

The places and spaces that make up Okotoks are designed with the environment in mind. Energy, air, land and water conservation are critical elements integrated into all planning and development projects. Okotoks is a leader in low-impact, environmentally conscious design. Creative resources, advanced technologies and respect for nature create an unique sense of place based on environmental stewardship. Regional and local transit provides an efficient transportation alternative and reduces vehicle use.

#### LOCAL ECONOMY

Okotoks-based employment and businesses strengthen the economy. Okotoks takes a collaborative approach to economic growth, creating new opportunities that complement the region. Okotoks promotes innovation and attracts green businesses and industries. A thriving downtown supports economic development. Okotoks is a place to live, work and play, where short commute times enable residents to actively engage in their community.

## **Guiding Principles**

#### **SEC TWO** SUSTAINABILITY CONTEXT

## Sustainability in Okotoks

The development of the Okotoks Community Sustainability Plan uses both a sustainability and resilience framework.

S ustainability is about understanding the relationship amongst community systems and making decisions today that will not have a negative impact on the future. The vision and guiding principles represent the diverse systems of the Okotoks community. While created as separate principles, these systems are all interrelated. The best solutions and actions will be ones that create positive change across multiple guiding principles.

Resilience is about moving towards the community's desired future while being adaptable to the inevitable changes that will occur in the future. Building a resilient community is an ongoing process, one that requires constant growth of knowledge and capacity in the community. In this way, Okotoks can be continually enhancing its ability to deal with (often unexpected) change as we move towards our vision of the future. By integrating leading thinking and practice on sustainability and resilience, a set of criteria was used during the community sustainability planning process.

The criteria applied were:

- · Protect and enhance diversity in all forms
- · Establish and promote local systems
- · Protect systems of natural habitat and resources
- · Ensure the greatest number of people can afford needed goods and services
- · Reduce gaps between rich and poor
- · Eliminate waste and conserve natural resources for future generations
- · Use collaborative decision-making including representatives from all sectors

Okotoks has a history of integrating sustainability and resilience into decision-making for the future. The Town of Okotoks became one of the first municipalities in the world to establish growth targets linked to infrastructure development and environmental carrying capacity when it adopted its **Legacy Plan** in 1998. The Town, dependent on the Sheep River for its water and its ability to treat and dispose effluent, faced a crossroad in 1998 – it could continue to "grow" and plan accordingly, or it could take a "road less traveled" and choose to live within the carrying capacity of the Sheep River watershed. Okotoks' carrying capacity in 1998 was identified as approximately 30,000 people. A build-out municipal boundary was established, with a set of targets and initiatives identified to ensure build-out population could be reached in an environmentally, economically, socially, and fiscally responsible way.

In 2012, due to external growth pressures in the region, the Town of Okotoks, after three years of public consultation, transitioned from the finite growth model of the 1998 Legacy Plan to one of continued managed growth. This decision was grounded in sustainability and resiliency; progressing our town's desire to responsibly manage our physical form and protect our community atmosphere while being adaptable to inevitable changes and external forces.

#### Present strengths and future forces

Building and maintaining a sustainable and resilient community is an ongoing process, one that requires continuous growth of knowledge and capacity within the community, including an understanding of what is working well today and what external forces may impact our community.

When navigating a course towards our desired future, it is vital to understand that Okotoks does not exist in a bubble. There are a variety of forces that will influence the community, regardless of what Okotoks does. The key is how the community responds and adapts to these changes over time, while still productively working towards our vision for the future.

As part of the process to develop the CSP, the project team also asked the community to share their thoughts on what assets exist today in Okotoks that are already working towards the Vision and Guiding Principles. This provides important information as the community works towards its desired future, as these are strengths that can be built upon.

These elements of the community help to build an excellent quality of life in Okotoks today. As we move into the future, we will continue to build on these assets and address other elements that need to be enhanced over time. Turn to the next page to read more about these strengths and forces >

## Sustainability Planning Process

The development of the Community Sustainability Plan built upon the extensive community engagement during the visioning process in 2014. From this starting point, the process comprised 4 key phases.

#### Phase 1 : Understand Success MAY - JUNE 2015

The project team reviewed the vision and guiding principles to establish a list of potential indicators that could be measured in the future. Measurement provides the community with real yardsticks of progress as actions build over time to realize the vision. This also provides a level of specificity on the broad statements found in the vision and guiding principles. Using sustainability and resilience criteria, the key indicators for each guiding principle were identified.

The results of this work are the Sustainability Indicators (to be finalized in 2016 - 2017).

#### Phase 2 : Forces of the Future JUNE - JULY 2015

Working with a diversity of staff from the Town of Okotoks, important future trends and threats were discussed, in order to understand the vision in context. Insights gained from this work provided the project team with an appreciation for the range of possible impacts on Okotoks, from a range of scales. Using sustainability and resilience criteria, these forces were prioritized based on their level of potential impact on the community into the future.


#### Phase 3 : Action Planning AUGUST - OCTOBER 2015


With an understanding of potential indicators and external forces that could influence Okotoks, the team engaged with the community on their ideas for actions that could take us towards our desired future.

Ideas were gathered through:

- A stakeholders workshop
- · An online feedback forum at okotoks.ca
- A Ideas Fair held at the Okotoks Recreation Centre

In addition, a workshop was held with a diversity of staff from the Town of Okotoks to understand organizational perspectives and capacity. A Council workshop was also held to identify key opportunities for initial action on the plan.





The results of this phase provided important insights into areas of priority action for the present and ideas for longer-term actions in the future. Using sustainability and resilience criteria, along with an assessment of priority action criteria, a set of critical first steps was established.

The results of this work can be found in Section Three - A Framework for Action on page 11.

#### Phase 4 : Plan Completion NOVEMBER 2015 - JANUARY 2016

The results of phases 1-3 were integrated into a draft Community Sustainability Plan, which was presented to the community. Citizens were able to share their thoughts on the plan through:

- An online feedback forum at okotoks.ca
- A public Ideas Fair held at the Okotoks Recreation Centre

#### SEC THREE A FRAMEWORK FOR ACTION

## Getting to Work

The challenge of moving towards a sustainable future is that there are too many options to take. As a result, focus is diluted. The Okotoks Community Sustainability Plan aims to take a different approach.

he Okotoks Community Sustainability Plan is focused on the actions that require initial focus, have the most impact and set the stage for future success. In order to facilitate constant learning and evaluation, it is also critical to consistently measure progress over time.

#### Arriving at the Actions You See Today

During the action planning phase of the project, the community provided a wide variety of ideas on how to move towards our guiding principles. These ideas ranged from the small and immediate to the longer term and ambitious. Each idea was considered and evaluated against two key filters: our sustainability and resilience criteria and our critical steps criteria. The result is the six critical steps identified here.

While not every idea is reflected in these initial steps on our way to a sustainable future, all of the ideas for action are shown in **Appendix B: Community Action Ideas** and will be part of the review for the next round of action planning in three years time.



#### Critical Steps

After engagement with the community and Town staff, a variety of options for action were identified. **Appendix B: Community Action Ideas** illustrates all the actions that were identified during the engagement. This array of actions was narrowed down to 6 Critical Steps, using the following criteria:

- The actions are achievable in the first 3 years of implementing the Community Sustainability Plan
- The actions establish a foundation for future actions
- The actions contribute to the future resilience of the community
- The actions address current gaps in the community
- The actions have concrete measures of success both in terms of actions and results
- The actions contribute to multiple guiding principles.

#### Measuring Progress

While the Critical Steps are the focus of initial activity, the Town of Okotoks will still continue delivering services to its citizens in all areas, working towards the vision and guiding principles. In order to evaluate progress, a set of indicators related to the guiding principles will be developed and monitored. In this way, the Town can continually reflect on where progress is being made and where new efforts are required.

The indicators will be built on the following:

- The indicators are aligned to guiding principles
- The indicators are focused on large-scale community results
- · The indicators reflect sustainability & resilience to work to "future proof" Okotoks


The Town will use the indicators to evaluate how its various business centres can contribute to progress on these indicators, allowing for more action towards the Vision beyond just the Critical Steps.

#### An Ongoing Process

By acting on early priorities while monitoring progress on the Guiding Principles, the Town will create an ongoing process to move towards the vision that Okotoks has created for itself. Every three years, the Critical Steps will be evaluated, along with a review of the indicators.

With this level of learning and understanding of how the community is moving towards its desired future, a new round of Critical Steps based on sound measurement and reflection can be identified. In this way, a regular process of acting, assessing and adapting can occur, making Okotoks more sustainable and resilient over time.
